All gifts will be forwarded as specified by the donor, less fourteen percent for processing and uncollectible expenses. If your agency is not eligible, or the provided information is incomplete, we will make every reasonable effort to contact you.

While corporate matching gifts are appreciated, we can not permit corporate matches to follow donor designations.
